 - c. Nominee must include a statement (100 words or less) to be distributed to the membership;**
 - d. Nominee must include a petition signed by at least 15 dues-paying members.**
- Petitions must be received** by the Nominations Committee, TAUP Office, 1900 North 13th Street, Barton Hall Room A-231, Philadelphia, PA 19122-6082, by **Friday, March 20, 2009**.
- Ballot information will be emailed** to all dues-paying members on or about **Monday, April 20, 2009**.

Ballot counts will be announced at a General Membership Meeting on **Thursday, April 30, 2009**, in the Paley Library Lecture Hall beginning at 1 pm.
